n the year of the Covid-19 pandemic, CADAL quickly adapted itself by organizing events virtually, publishing articles, reports, and books, and working on exchanges with colleagues from civil societies. All of this, amid important organizational changes that included the redesign of the website, the definition of five projects with their respective initiatives, and the renewal of part of the staff.

In 2020 CADAL organized three face-to-face events:

- 1) In Punta del Este, Uruguay, the Latin American Forum about the political situation in Argentina and Uruguay.
- 2) A workshop held in closed sessions, dedicated to "Freedom of association in favor of human rights and freedom of the media".
- 3) "Human rights, challenges in activism in Latin America", a public conference.

There were 34 events more during 2020 that were held virtually, in which a total of 130 exhibitors participated throughout the year.
